

COVERAGE WHILE CARRYING PERSONS FOR A CHARGE

This endorsement is a part of the policy. Except for the changes this endorsement makes, all other provisions of the policy remain the same and apply to this endorsement.

1. LIABILITY COVERAGE

Exclusions

Exclusion 7. is changed to read:

THERE IS NO COVERAGE FOR AN **INSURED** FOR DAMAGES ARISING OUT OF THE OWNERSHIP, MAINTENANCE, OR USE OF A VEHICLE:

- a. DURING THE PERIOD OF TIME AN **INSURED**, WHILE LOGGED ON TO A TRANSPORTATION NETWORK COMPANY'S DIGITAL NETWORK AS A DRIVER, IS A DRIVER OF THAT VEHICLE; OR
- b. WHILE IT IS BEING USED TO CARRY **PERSONS** FOR A CHARGE. This exclusion (7.b.) does not apply:
 - (1) to the use of a **private passenger car** on a share-the-expense basis;
 - (2) to **you** or a **resident relative occupying a non-owned car**, or
 - (3) if the carrying of **persons** is incidental to the **insured's** business or occupation.

2. MEDICAL PAYMENTS COVERAGE

Exclusions

Exclusion 4. is changed to read:

THERE IS NO COVERAGE FOR AN **INSURED** WHO IS **OCCUPYING** A VEHICLE:

- a. DURING THE PERIOD OF TIME AN **INSURED**, WHILE LOGGED ON TO A TRANSPORTATION NETWORK COMPANY'S DIGITAL NETWORK AS A DRIVER, IS A DRIVER OF THAT VEHICLE; OR
- b. WHILE IT IS BEING USED TO CARRY **PERSONS** FOR A CHARGE. This exclusion (4.b.) does not apply:
 - (1) to the use of a **private passenger car** on a share-the-expense basis;
 - (2) to an **insured** while **occupying a non-owned car** as a passenger; or
 - (3) if the carrying of **persons** is incidental to the **insured's** business or occupation;

3. UNINSURED/UNDERINSURED MOTORIST COVERAGE

Exclusions

Exclusion 9 is changed to read:

THERE IS NO COVERAGE FOR AN **INSURED** WHO IS **OCCUPYING** A VEHICLE:

- a. DURING THE PERIOD OF TIME AN **INSURED**, WHILE LOGGED ON TO A TRANSPORTATION NETWORK COMPANY'S DIGITAL NETWORK AS A DRIVER, IS A DRIVER OF THAT VEHICLE; OR
- b. WHILE CARRYING **PERSONS** FOR A CHARGE. This exclusion (9.b.) does not apply to:
 - (1) the use of a **private passenger car** on a share-the-expense basis;
 - (2) **you** or a **resident relative occupying a non-owned car** as a passenger; or
 - (3) if the carrying of persons is incidental to the insured's business or occupation;

4. PHYSICAL DAMAGE COVERAGES

Exclusions

Exclusion 3. is changed to read:

THERE IS NO COVERAGE FOR ANY **COVERED VEHICLE**:

- a. DURING THE PERIOD OF TIME THE DRIVER OF THE **COVERED VEHICLE** IS LOGGED ON AS A DRIVER TO A TRANSPORTATION NETWORK COMPANY'S DIGITAL NETWORK; OR

- b. WHILE IT IS BEING USED TO CARRY **PERSONS** FOR A CHARGE. This exclusion (3.b.) does not apply to:
- (1) the use of a **private passenger car** on a share-the-expense basis; or
 - (2) If the carrying of **persons** is incidental to the **insured's** business or occupation.
